Executive Summary

The FCA Association organized multiple successful community outreach event, providing essential resources and support to vulnerable populations in need. Volunteers distributed food, making a positive impact on the lives of those facing hardship. At the same time, the FCA Association forged strategic partnerships with local businesses to support its charitable initiatives. Through collaborative efforts, the organization secured donations and sponsorships to fund critical programs and services for the community. Volunteers were honoured for their invaluable contributions to the organization's mission, inspiring others to get involved and make a difference.

Impact and Outcomes

With the pilot LLAMA project, we were able to reach 9 families with material help and upskill our members for further stages of the project. We provided a training to better winter hiking skills to decrease the risk of fatalities while hiking. This project helped to train 5 individuals. We have provided a socializing and recreational platform to around 600 people of Polish, Scottish and other origins through our GOCC project. We are providing a regular socializing and sports opportunity to 30 individuals weekly with our football trainings. Through our volunteering engagement, we were able to find opportunities for about 40 people in total. Members and non-members to improve the lives of others.

Our organization ran the first project for the public, which was fully supported and paid by a sponsor. It was "Safety in Mountains" project, focusing on learning winter skills needed in mountains to hike safely in the

harsh, winter conditions. It was two days, weekend course, the first of the upcoming series of courses and

events.

Thorough the Mapa project, we have organized (as co-organizer) a 300+ people event, which connected Scots

and Polish people. We are currently extending this endeavour by cooperating on a Youtube channel and more.

All to provide a better link between Scottish and Polish cultures.

Financial Performance

We are currently at about, 8150 GBP of annual turnover and 2540 GBP available funds on our account.

Compliance and Governance

We currently have 30 registered members, and we have completed our first elections on the 11th of March

2024. We have a healthy account balance and have not found any issues with the charitable purposes we are

providing.

Challenges and Opportunities

Low financial turnover and lack of partners were our main issues for grants rejection initially. We have worked hard in this area over the last 3 months and could see many improvements. Our biggest challenge remains to be the lack of our own building to be able to offer a community house (more outlined in our strategy for 2024).

Looking Ahead

Our capabilities have significantly grown since, and we have decided we will need to amend our constitution to be able to offer a wider set of services to the community. We also still have about 12 different activities and 10 wider projects planned for this and next financial year.
